## Terms and conditions for enrollment

This Enrollment Contract (referred to as the "Contract") is entered into between the parent/guardian (referred to as "Parents") and Dance Academy, Virginie Capbert (referred to as the "School") for the enrollment of the student (referred to as the "Student(s)") in ballet classes offered by the School. The Contract remains valid for the duration of the student's enrollment in the School, subject to the conditions outlined herein.

It is important to note that while these terms and conditions are applicable throughout the student's enrollment, the School reserves the right to modify or amend them as necessary. In the event of any changes, the Parents and Students will be promptly notified and provided with updated information. It is the responsibility of the Parents and Students to review and acknowledge any modifications made to the terms and conditions.

By entering into this Contract, the parties involved hereby agree to abide by the following terms and conditions.

### 1. School Periods and Fees:

The ballet school operates in three periods throughout each year:

- Period 1: August 1st to November 30th
- Period 2: December 1st to March 31th
- Period 3: April 1st to July 31st

The fees for classes are as follows:

- 50-minute class: CHF 320 per period
- 60-minute class: CHF 370 per period
- 70-minute class: CHF 400 per period

A 10% discount is offered for siblings and for the second class taken by the same child. These discounts cannot be combined.

### 2. Annual Performance:

Fees related to the participation in performances organized by the school are included in the general enrollment fees.

Rehearsals for the annual performance are spread over multiple periods. Parents are encouraged to allow their child to participate. However, if the Student will not be participating, Parents must inform the School as soon as possible, since costumes and choreographies are planned several months in advance.

### 3. Subscription and Cancellation:

By default, subscription to the ballet school is renewed for the following period. Each dancer's place is automatically reserved for the following period.

If parents wish to cancel the subscription for the following period, they must inform the School at least one calendar month before the end of the current period.

Deadline for cancellation:

- June 30th to stop at the end of Period 3
- October 31st to stop at the end of Period 1
- February 28th/29th to stop at the end of Period 2

Failure to provide advance notice of unsubscription results in billing for the entire following period of fees. Parents are requested to inform the School in a timely manner to avoid any inconvenience and to allow necessary arrangements to be made.

#### 4. Payment Options:

Payment for each period is due at the beginning of that period.

The School offers three convenient payment options: TWINT, cash, or bank transfer. Parents may choose their preferred payment method, and the School will provide the necessary details accordingly.

#### 5. School Calendar:

The ballet school follows the school calendar of Küssnacht. There will be no classes or rehearsals during official school holidays or any other scheduled breaks or days without school in the Küssnacht academic calendar.

#### 6. Attendance and Makeup Classes:

Regular attendance is essential for the progress and development of the Student(s). Parents are requested to ensure that the Student(s) attend classes consistently and arrive on time.

Every missed class can be made up on a different day, subject to agreement. Parents must communicate any missed classes as soon as possible so that the School can coordinate a makeup class that works for both the Student(s) and the instructor.

#### 7. Parents watching the class:

Parental Presence: To ensure optimal focus and benefit for the children, parents are kindly requested to not enter the studio during the class.

Occasional Viewing: If parents wish to very occasionally watch a class, they must request permission from the teacher in advance. Parents should approach the teacher and ask to observe the class, preferably with prior notice. The teacher will consider the feasibility and make arrangements for parental viewing, considering the class dynamics and available space.

#### 8. Photos/videos :

By default, I give the ballet school full rights to use the images resulting from photography and video filming. I grant permission for the ballet school to use the photographs and videos, including any reproductions or adaptations, for publicity or other purposes to help the ballet school achieve its goals. This includes, but is not limited to, the right to use the photographs and videos in printed and online publicity, the ballet school's website, social media platforms, press releases, and funding applications.

The photographs and videos may be taken during dance classes, rehearsals, and public performances organized by the ballet school.

The ballet school will make efforts to respect the privacy of the Student(s) and will not disclose personal information without additional consent. The ballet school will take reasonable measures to ensure that photographs and videos are used in a responsible and respectful manner.

Revocation of Consent: I understand that I have the right to revoke this consent at any time by providing written notice to the ballet school. Revoking consent will not affect any photographs or videos taken before the revocation.
